2. MME agrees to have the photobooth fully operational for a minimum of 80% during the period, occasionally, operations may need to be interrupted for service and/or photography optimizations. All rentals include 4 hours of continuous service. Booth delivery will be available 1 hour prior to the contract start time. If installation is required before that, a \$75.00 fee will apply.

If mediation is unsuccessful the dispute will be settled by binding arbitration. The laws of the province of Ontario shall govern this Agreement. The parties agree that this Agreement is the entire agreement between them. This Agreement binds and benefits both MME and Client and any successors.
